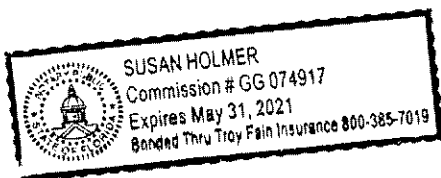

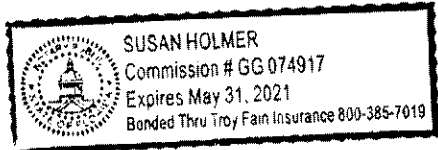

**AMENDMENTS TO
DECLARATION OF CONDOMINIUM OF
NEVIS AT COVE TOWERS PRESERVE, A CONDOMINIUM**

The Declaration of Condominium of Nevis at Cove Tower Preserve, a Condominium, is hereby amended as set forth below:

7. COMMON ELEMENTS.

[Sections 7.1 through 7.2 remain unchanged]

7.3 MATERIAL ALTERATIONS AND ADDITIONS. Except for changes made by an owner with Board approval as provided in Section 6.5 above, or by the Board of Directors alone for the integrity of this Condominium's property, material alteration of or substantial additions to the common elements of this Condominium including the purchase acquisition, sale, conveyance, or mortgaging of such property may be effectuated only by vote of 6760% of the voting interests of this Condominium at a meeting called for that purpose. There shall not be any material alterations or substantial additions made to Association Real Property unless approved by the vote of 6760% of the voting interests of the Association; provided however, that such changes may be made by the Board of Directors alone if necessary for the integrity of the Association Real Property. The Board of Directors, without any vote of the membership, is authorized to lease or grant easements or licenses for the use of the common elements or Association property to unit owners or other persons, if in the judgement of the Board, the use will benefit the members of the Association, even where the lease, easement, or license would result in a material alteration or substantial addition to the common elements or Association property. The Association may charge for such use.
